### **UAPF held online webinars for employees of the Almaty Regional Bar Association**

UAPF JSC regularly holds various events to improve the financial literacy of the population. Since the beginning of 2024, the branches of the Fund have held more than 35.3 thousand road presentations as part of information and explanatory work, which were attended by about 740.3 thousand people. On November 29 and December 6 of this year, the next online webinars were held for employees of the Almaty Regional Bar Association.

During the events, moderated by Deputy Chairperson of the Executive Board of UAPF JSC Saule Yegeubayeva, the Fund's specialists acquainted the participants with the structure of the pension system of Kazakhstan. In particular, the Strategic Development Director Kamilya Fazylova spoke about examples of different types of pension systems in the world, the advantages of the funded system, pension services provided by UAPF to the population, as well as various aspects of the investment activities of the National Bank of the Republic of Kazakhstan as the main manager of the Fund and investment portfolio managers. In turn, Deputy Director of the Benefits and Information Gulmira Kimolayeva acquainted the participants with the types of pension benefits and the algorithm for receiving them for different categories of citizens. During the second online webinar, the Head of the Benefit Payment Methodology of the Benefits and Information G. Agaydarova, the Legal Director N. Baktybayev and the Head of the Pension Activities Legal Support M. Syzdykova spoke in detail about the procedures for providing pension benefit payment services in various situations, about judicial practice in UAPF and the secrecy of pension savings of contributors. After a detailed presentation, the Fund's specialists answered questions from representatives of the Almaty Regional Bar Association.

The founder and shareholder of the UAPF is the Government of the Republic of Kazakhstan represented by the State Institution Committee of State Property and Privatization of the Ministry of Finance of the Republic of Kazakhstan. Trust management of UAPF pension assets is carried out by the National Bank of the Republic of Kazakhstan. In accordance with the pension legislation, the UAPF attracts compulsory pension contributions, employer's compulsory pension contributions, compulsory occupational pension contributions, voluntary pension contributions, as well as carries out enrollment and accounting of voluntary pension contributions formed at the expense of the unclaimed amount of guaranteed compensation for the guaranteed deposit, transferred by the organization carrying out mandatory guarantee of deposits, in accordance with the Law of the Republic of Kazakhstan "On mandatory guarantee of deposits placed in second-tier banks of the Republic of Kazakhstan", ensures the implementation of pension benefits. The Fund also carries out accounting of target assets and target requirements, accounting and crediting of target savings (TS) to target savings accounts, payments of TS to their recipients in bank accounts, accounting for returns of TS in the manner determined by the Government of the Republic of Kazakhstan within the framework of the National Fund for Children program (More details at [www.enpf.kz](http://www.enpf.kz))*
